

STEPS FOR APPLYING TO THE GRCCA FOR DUAL ENROLLMENT

📄 Read the requirements for admission to the GRCCA, Gordon State College (GSC), and Southern Crescent Technical College (SCTC). → 📄 Review the programs available at the GRCCA. → Decide if you want to apply to GSC or SCTC.

Apply for admission to the college directly.

📄 Print an application, complete it, and mail it directly to the college. There is no fee for paper applications for dual enrollment students. You will have to pay a fee if you use the online application.

Request an official transcript from your high school and ask that it be sent directly to the college. You can also hand-deliver an official transcript in a sealed envelope to the admissions office.

If you have applied to SCTC, if you are in 11th or 12th grade, and if your HOPE Calculated GPA is a 2.6 or 2.0 (for different programs), you will not be required to submit test scores as part of your application.

 - ◆ Admitted to workforce certificate programs at SCTC (e.g., Cosmetology, Welding)
